

This Privacy and Cookies Policy describes the way **Pri-Med Global Exhibitions Ltd** collects and uses the personal information of users of this website.

Who are we?

Collection and Use of Personal Information

Personal information collected from you may include your name, payment information, postal address, email address, landline or mobile telephone number, delivery details as well as other personal information you provide to us. We may collect and process personal information about you as follows:

Will we share your information with third parties?

We may exchange information with other companies and organisations for the purposes of the prevention and detection of criminal or unlawful behaviour, fraud protection and credit risk reduction.

SECURITY OF PERSONAL INFORMATION

We use administrative, technical, and physical measures to safeguard personal information against loss, theft and unauthorised uses, access or modifications. Certain areas of our website may be password protected. If you are a user of our website and have a password, you can help to preserve your privacy by ensuring that you do not share your password with anyone else.

We take steps to regularly validate the personal information we hold to ensure that the information is accurate and, where necessary, up to date.
